OCA CIRCULAR NO. 75-2013

**TO : THE CONCERNED TRIAL COURT JUDGES**

**SUBJECT : MEETINGS FROM JUNE 6 TO 13, 2013 OF THE TOPICAL WORKING GROUPS (TWGs) OF THE NATIONAL CONFERENCE FOR THE REVISION OF THE RULES OF CIVIL PROCEDURE**

The Supreme Court, the Integrated Bar of the Philippines, and the UP Law Center will hold a National Conference for the Revision of the Rules of Civil Procedure. The Core Committee for the National Conference had conducted several regional consultations/dialogues on the first draft of the new rules. As a result, the Committee had solicited several comments and suggestions from stakeholders, particularly from trial court judges.
