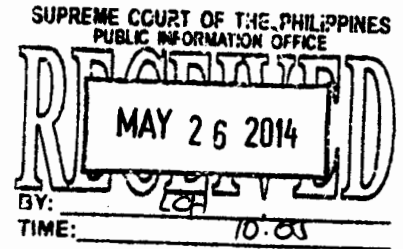

ADMINISTRATIVE ORDER
NO. 53-2014

In the interest of an efficient administration of justice and pursuant to Sec. 5(3), Art. VIII of the Constitution, the **Hon. ROBERTO A. ESCARO**, Presiding Judge, Branch 38, Regional Trial Court (RTC), Daet, Camarines Norte, is hereby **DESIGNATED** as Acting Presiding Judge of Branch 64, RTC, Labo, Camarines Norte, in addition to his regular duties in his own court, effective immediately, and to continue until the appointment and assumption to duty of the regular judge thereat or until further orders from this Court.

Judge Escaro shall be entitled to additional expense allowance and judicial incentive allowance, as provided for in the Resolution dated 2 February 1999 of the Court En Banc in A.M. No. 99-1-04-SC, as amended.

This revokes the designations of Judge Arniel A. Dating as Assisting Judge of Branch 40, RTC, Daet, Camarines Norte, pursuant to Administrative Order No. 137-2009 dated 7 October 2009 and as Acting Presiding Judge of Branch 64, RTC, Labo, Camarines Norte, pursuant to Administrative Order No. 39-2013 dated 27 February 2013.
