
**ADMINISTRATIVE ORDER
NO. 57-2014**

In the interest of an efficient administration of justice and pursuant to Section 5 (3), Art VIII of the Constitution, the **Hon. RUFO U. NARAGAS**, Presiding Judge, Branch 40, Regional Trial Court (RTC), Tandag City, Surigao del Sur, is hereby **DESIGNATED** as Assisting Judge of Branch 29, Regional Trial Court, Bislig City, Surigao del Sur to try and decide all inhibited cases of Presiding Judge Merlyn B. Pacaro-Cañedo, in addition to his regular duties in his own court, effective immediately and to continue until further orders from this Court.

Judge Naragas shall be entitled to reimbursement of traveling expenses with *per diems* and an additional expense allowance and judicial incentive allowance as provided for in the Resolution of the Court En Banc dated February 2, 1999, as amended.

This Order revokes the designation of Judge Edwin M. Malazarte pursuant to Administrative Order No. 157-2013 dated 27 August 2013.
