ADMINISTRATIVE ORDER
NO. 65-2014

In the interest of an efficient administration of justice and pursuant to Section 5 (3), Art. VIII of the Constitution, **Hon. RIC S. BASTASA**, Presiding Judge, Municipal Trial Court (MTC), Manuel A. Roxas, Zamboanga del Norte, is hereby **DESIGNATED** as Acting Presiding Judge of the 6th Municipal Circuit Trial Court (MCTC), Labason-Gutalac-Kalawit and the 9th MCTC, Salug-Godod, both in Zamboanga del Norte, in addition to the regular duties in his own court, effective immediately and to continue until the appointment and assumption to duty of the regular judges thereat or until further orders from this Court.

Judge Bastasa shall be entitled to reimbursement of traveling expenses with per diems and additional expense allowance and judicial incentive allowance as provided for in the Resolution of the Court En Banc dated February 2, 1999, as amended.

This revokes the designation of Presiding Judge Vittorino Dante D. Dalman, 1st MCTC, Rizal-Sibutad, Zamboanga del Norte, as Acting Presiding Judge of the 6th MCTC, Labason-Gutalac-Kalawit, Zamboanga del Norte and 9th MCTC, Salug-Godod, Zamboanga del Norte, pursuant to Administrative Order No. 186-2013 dated 23 October 2013.
