ADMINISTRATIVE ORDER
NO. 66-2014

For a more efficient administration of justice and pursuant to Sec. 5 (3) Article VIII of the Constitution, the following judges are hereby **DESIGNATED** as Acting Presiding Judge, in addition to their regular duties in their own courts, effective immediately, and to continue until the appointment and assumption to duty of the regular presiding judges thereat, or until further orders from this Court, to wit:

- 1.) **Hon. GLENDA CHING-GO**, Presiding Judge, Branch 65, Regional Trial Court, Talisay City, Cebu, as Acting Presiding Judge of Branch 55, Regional Trial Court, Mandaue City, Cebu; and
- 2.) **Hon. JACINTO G. FAJARDO, JR.**, Presiding Judge, Branch 66, Regional Trial Court, Talisay City, Cebu, as Acting Presiding Judge of Branch 13, Regional Trial Court, Cebu City, Cebu.

As Acting Presiding Judge and Assisting Judge, Judges Ching-Go and Singco-Caruso shall **DIVIDE EQUALLY** all the cases in Branch 55, Regional Trial Court, Mandaue City, Cebu, whether newly-filed or in the trial stage. However, all cases left unresolved or undecided by Judge Ramon B. Daomilas, Jr. shall be resolved or decided by Judge Ching-Go.


Judges Ching-Go, Singco-Caruso and Fajardo shall be entitled to reimbursement of traveling expenses with *per diems* and additional

expense allowance and judicial incentive allowance as provided for in the Resolution of the Court En Banc dated 2 February 1999 in Administrative Order No. 99-1-04-SC, as amended.

This order revokes the designation of Judge Jacinto G. Fajardo, Jr. as Acting Presiding Judge of Branch 55, Regional Trial Court, Mandaue City, Cebu and the distribution of cases between the Acting Presiding Judge Fajardo and Assisting Judge Singco-Caruso, pursuant to Administrative Order No. 54-2014 dated 27 March 2014, and the designation of Judge Ching-Go as Acting Presiding Judge in Branch 13, Regional Trial Court, Cebu City, Cebu, pursuant to Administrative Order No. 56-2014 dated 7 April 2014. And amends the designation of Judge Singco-Caruso as Assisting Judge of Branch 55, Regional Trial Court, Mandaue City, Cebu, pursuant to Administrative Order No. 68-2011 dated 26 April 2011.
