ADMINISTRATIVE ORDER
NO. 67-2014

For a more efficient administration of justice and pursuant to Section 5 (3), Art VIII of the Constitution, the following are hereby **DESIGNATED** as Acting Presiding Judges:

1. **Hon. FRANCISCO J. CORDERO, JR.**, Presiding Judge, Municipal Circuit Trial Court (MCTC), Lebak-Kalamansig, Sultan Kudarat, as Acting Presiding Judge of the Municipal Trial Court, Maasim, Sarangani, in addition to his regular duties in his own court effective immediately and to continue until the appointment and assumption to duty of the regular judge thereat, or until further orders from this Court; and
2. **Hon. MAMERTO C. PANAL, JR.**, Presiding Judge, MCTC, Malungon-Alabel, Sarangani, as Acting Presiding Judge of the MCTC, Glan-Malapatan, Sarangani, effective immediately and to continue until the assumption to duty of the newly appointed judge thereat, or until further orders from this Court.


Both judges shall be entitled to reimbursement of traveling expenses with per diems and an additional expense allowance and judicial incentive allowance as provided for in the Resolution of the Court En Banc dated February 2, 1999, as amended.
