SUBJECT : FRAUDULENT MISREPRESENTATION OF ANDRES CULANAG
 AS ATTY. FILEMON MANANGAN OR ATTY. BENJAMIN M.
 FACUN

For the information and guidance of all concerned, quoted
 hereunder are pertinent portions of the Decision of the Second
 Division, this Court, promulgated on August 30, 1990, in G.R.
 No. 82760 entitled "Felimon Manangan vs. Court of First Instance
 of Nueva Vizcaya, Branch 28", to wit:

"It is the height of chicanery, indeed, that
 despite the foregoing antecedents, petitioner
 still has the gall to claim that he is, in truth
 and in fact, Filemon Manangan. The evidence on
 hand, without need for more, and with petitioner
 having been sufficiently heard, amply establish-
 es that petitioner Filemon Manangan, is an
 impostor. He is guilty of continued fraudulent
 misrepresentation and highly improper conduct
 tending directly to impede, obstruct, degrade,
 and make a mockery of the administration of
 justice (Rule 71, Sec. 3[6]).

"WHEREFORE, xxxxx (2) petitioner is adjudged
 in contempt of Court, severely censured, and
 sentenced to suffer three (3) months imprison-
 ment, the same to same to be served at the
 Provincial Jail of Nueva Vizcaya to ensure


