ADMINISTRATIVE ORDER
NO. 28-2015

RE : DESIGNATION OF JUDGES AS OBSERVERS AND ALTERNATES IN THE IBP LOCAL ELECTIONS ON 28 FEBRUARY 2015

Acting on the letter-request dated 20 January 2015 of Atty. Vicente M. Joyas, National President, Integrated Bar of the Philippines (IBP), for the designation of official court observers for the scheduled IBP local elections pursuant to Section 15, Article 1 of the By-Laws of the IBP, the judges listed below are hereby designated as official observers and alternates in the IBP local elections to be held on 28 February 2015.

As observers and alternates, judges concerned will coordinate with the Chapter President in their respective areas. Within ten (10) days from the date of the election, a report should be submitted to the Office of the Court Administrator which should include the following: a list of the officers duly elected and the offices to which they were elected; any incident that may constitute any prohibited acts and practices relative to elections provided for in Section 14, Article 1 of the By-Laws of the IBP; and any other matter that in their opinion should be brought to the attention of this Office.
