SUBJECT: 2ND **TRAINING** ON **COMPETENCY** PILOT **TRAINING FOR** JUDGES, **ENHANCEMENT** SOCIAL WORKERS, AND LAW PROSECUTORS, HANDLING ENFORCEMENT INVESTIGATORS IN ONLINE SEXUAL EXPLOITATION CHILDREN CASES
