## OCA CIRCULAR NO. 249-2018

SUSPENSION OF ATTY. RAMON Y. GARGANTOS, SR. FROM THE PRACTICE OF LAW FOR SIX (6) MONTHS

For your information and guidance, quoted hereunder is the Decision dated 27 June 2018 of the Second Division in Administrative Case No. 11326, entitled "Pelagio Vicencio Sorongon, Jr. vs. Atty. Ramon Y. Gargantos, Sr.," to wit:

WHEREFORE, respondent Atty. Ramon Y. Gargantos, Sr., is hereby SUSPENDED from the practice of law for six (6) months effective immediately upon receipt of this Decision and warned that a repetition of the same or similar acts will be dealt with more severely. Respondent Atty. Gargantos, Sr. is ordered to RETURN to complainant Pelagio Vicencio Sorongon, Jr. the amount of Two Hundred Thousand Pesos (\$\neq\$200,000.00) within ninety (90) days from the receipt of this Decision, including the documents in respondent's possession which pertain to the case of the complainant. Failure to comply with the foregoing directive will warrant the imposition of a more severe penalty.

Let copies of this Decision be furnished the Office of the Bar Confidant, to be appended to respondent's personal record as attorney. Further, let copies of this Decision be furnished the Integrated Bar of the Philippines and the Office of the Court Administrator, which is directed to circulate them to all courts in the country for their information and guidance.
