OCA CIRCULAR NO. 114-2019

TO : THE COURT OF APPEALS, SANDIGANBAYAN, COURT OF TAX APPEALS, REGIONAL TRIAL COURTS, SHARIA DISTRICT COURTS, METROPOLITAN TRIAL COURTS, MUNICIPAL TRIAL COURTS IN CITIES, MUNICIPAL TRIAL COURTS, MUNICIPAL CIRCUIT TRIAL COURTS, SHARIA CIRCUIT COURTS, THE OFFICE OF THE CHIEF STATE PROSECUTOR, PUBLIC ATTORNEY'S OFFICE AND THE INTEGRATED BAR OF THE PHILIPPINES

SUBJECT : SUSPENSION OF ATTY. DELFIN R. AGCAOILI, JR. FROM THE PRACTICE OF LAW FOR TWO (2) YEARS AND REVOCATION OF HIS NOTARIAL COMMISSION AND DISQUALIFICATION FROM REAPPOINTMENT AS NOTARY PUBLIC FOR TWO (2) YEARS

For your information and guidance, quoted hereunder is the dispositive portion of the Decision dated 26 June 2018 of the Court *En Banc* in Administrative Case No. 12011, entitled "Nicanor D. Triol vs. Atty. Delfin R. Agcaoili, Jr.," to wit:

WHEREFORE, the Court finds respondent Atty. Delfin R. Agcaoili, Jr. (respondent) **GUILTY** of violating the 2004 Rules on Notarial Practice and the Code of Professional Responsibility. Accordingly, the Court hereby **SUSPENDS** him from the practice of law for a period of two (2) years; **PROHIBITS** him from being commissioned as a notary public for a period of two (2) years; and **REVOKES** his incumbent commission as a notary public, if any. He is **WARNED** that a repetition of the same offense or similar acts in the future shall be dealt with more severely.


The suspension in the practice of law, the prohibition from being commissioned as notary public, and the revocation of his notarial commission, if any, shall take effect immediately upon receipt of this Decision by respondent. He is **DIRECTED** to immediately file a Manifestation to the Court that his suspension has started, copy furnished all courts and

quasi-judicial bodies where he has entered his appearance as counsel.

Let copies of this Decision be furnished to the Office of the Bar Confidant to be appended to respondent's personal record as an attorney; the Integrated Bar of the Philippines for its information and guidance; and the Office of the Court Administrator for circulation to all courts in the country.

In a Resolution dated 16 October 2018, the Court *En Banc* DENIED WITH FINALITY the respondent's Motion for Reconsideration, there being no substantial matters to warrant the reversal of the questioned Decision dated 26 June 2018. Per Registry Return Receipt No. 121819, respondent received a copy of the Resolution denying his motion for reconsideration on 20 November 2018.
