SUBJECT

INCLUSION OF THE CHILDREN CONFLICT WITH THE LAW (CICL) DATA IN THE REPORTS **BEING SUBMITTED** THE FAMILY COURTS TO THE **OFFICE** THE COURT **ADMINISTRATOR** RELATIVE TO THE NUMBER OF CASES UNDERGOING **DIVERSION** AND DISPOSITION

Pursuant to the 18 June 2019 Resolution in **A.M. No. 02-1-18-SC** (Re: Rule on Juveniles in Conflict with the Law), the Court En Banc **APPROVED** the inclusion of the Children in Conflict with the Law (CICL) Data in the reports being submitted by the Family Courts to the Office of the Court Administrator (OCA), which shall include the number of cases undergoing diversion and disposition. The Reporting Templates on CICL, herein attached as Annexes "A" and "B", shall be accomplished by the Family Courts as an addendum to the Monthly Reporting Template prescribed by the OCA.
