ADMINISTRATIVE ORDER
NO. 54-2014

For a more efficient administration of justice and pursuant to Sec. 5 (3) Article VIII of the Constitution, **Hon. Jacinto G. Fajardo, Jr.**, Presiding Judge, Branch 66, Regional Trial Court, Talisay City, Cebu, is hereby **DESIGNATED** as Acting Presiding Judge of Branch 55, Regional Trial Court, Mandaue City, Cebu, in addition to his regular duties in his own court, effective immediately, and to continue until the appointment and assumption to duty of the regular presiding judge thereat, or until further orders from this Court.

Hon. Estela Alma A. Singco-Caruso, Presiding Judge, Branch 12, Regional Trial Court, Cebu City, and Assisting Judge of Branch 55, Regional Trial Court, Mandaue City, Cebu, pursuant to Administrative Order No. 68-2011 dated 26 April 2011, is **DIRECTED** to hear and decide all newly-filed cases she has taken cognizance of prior to the assumption to duty of Judge Fajardo as Acting Presiding Judge of Branch 55, Regional Trial Court, Mandaue City, Cebu, until they are disposed. Thereafter, all newly-filed cases shall be taken cognizance by Judges Fajardo and Singco on the ratio of 1:1.

Judges Fajardo and Singco-Caruso shall **DIVIDE EQUALLY** all cases that will be left unresolved or decided by Judge Ramon B. Daomilas, Jr. and take appropriate action thereon.


Judge Jacinto shall be entitled reimbursement of traveling expense with *per diems* and additional expense allowance and judicial incentive
