
In the interest of an efficient administration of justice and pursuant to Sec. 5 (3), Art. VIII of the Constitution, the following judges are hereby DESIGNATED as Acting Presiding judges:

- a.) **HON. AVELINA J. VILLEGAS-ROSARIO**, Presiding Judge, Municipal Trial Court (MTC), Calasiao, Pangasinan, as Acting Presiding Judge of the 3rd Aguilar-Bugallon, Pangasinan, in addition to her regular duties in her own court, effective immediately, and to continue until the appointment and assumption to duty of the regular presiding judge thereat or until further orders from this Court, and

- b.) **HON. EDWIN B. MAYNIGO**, Presiding Judge, MTC, Lingayen, Pangasinan, as Acting Presiding Judge of the MTC, Binmaley, Pangasinan, in addition to his regular duties in his own court, effective immediately, and to continue until the appointment and assumption to duty of the regular presiding judge thereat or until further orders from this Court.

Judges Rosario and Maynigo shall be entitled to reimbursement of traveling expenses with per diems and additional expense allowance, and judicial incentive allowance as provided for in the Resolution of the Court En Banc dated 2 February 1999 in A.M. No. 99-1-04-SC as amended.
