NO. 63-2014


In the interest of an efficient administration of justice, **HON. NELSON A. TRIBIANA**, Presiding Judge, Branch 37, Baloc, Sto. Domingo, Nueva Ecija, is hereby **DESIGNATED** Acting Presiding Judge of Branch 2, Regional Trial Court, City of Balanga, Bataan, in addition to his regular duties at his own court, effective immediately, and to continue until the appointment and assumption to duty of the regular presiding judge thereat, or until further orders from this Court.


This revokes the designation of Judge Ancheta as Acting Presiding Judge of Branch 2, RTC, City of Balanga, Bataan.

Judge Tribiana shall be entitled to additional expense allowance and judicial incentive allowance, as provided for in the Resolution of the Court En Banc dated 2 February 1999 in A.M. No. 99-1-04-SC, as amended.
