
ADMINISTRATIVE ORDER
NO. 73-2014

In the interest of an efficient administration of justice and pursuant to Sec. 5(3), Art. VIII of the Constitution, the following are hereby **DESIGNATED** as Assisting Judges, in addition to their regular duties in their own courts, effective immediately, and to continue until further orders from this Court, to wit:

1. **HON. IRA FRITZIE C. CRUZ-ROJO**, Presiding Judge, Branch 3, Municipal Trial Court in Cities (MTCC), Antipolo City, Rizal, as Assisting Judge of Branch 1, MTCC, Antipolo City, Rizal; and
2. **HON. ELENITA C. DIMAGUILA**, Presiding Judge, Branch 4, MTCC, Antipolo City, Rizal, as Assisting Judge of Branch 2, MTCC, Antipolo City, Rizal.

Accordingly, Judges Rojo and Dimaguila shall take cognizance of all newly-filed cases as well as all pending cases which have not yet reached the pre-trial stage in civil cases and where the accused have not yet been arraigned in criminal cases, and they shall be entitled to additional expense allowance and judicial incentive allowance, as provided for in the Resolution dated 2 February 1999 of the Court En Banc in A.M. No. 99-1-04-SC, as amended.
