**SUBJECT :** SUSPENSION OF ATTY. MARVIN C. YANG-ED FROM THE PRACTICE OF LAW FOR ONE (1) YEAR

For your information and guidance, quoted hereunder is the dispositive portion of the Resolution dated 02 October 2019 of the Second Division in A.C. No. 12119, titled "Jesus C. Soriano vs. Atty. Marvin C. Yang-Ed," to wit:

WHEREFORE, Atty. Marvin C. Yang-Ed is found **GUILTY** of violation of Canon 17 and Canon 18, Rules 18.03 and 18.04 of the Code of Professional Responsibility. Accordingly, he is **SUSPENDED** from the practice of law for **ONE (1) YEAR** effective immediately upon receipt of this Resolution with **STERN WARNING** that a repetition of the same or any similar act shall be dealt with more severely.


He is required to formally inform the Court within a non-extendible period of five (5) days from notice of the exact date of receipt of receipt of this Resolution.
