OCA CIRCULAR NO. 110-2020

TO : THE COURT OF APPEALS, SANDIGANBAYAN, COURT OF TAX APPEALS, REGIONAL TRIAL COURTS, SHARIA DISTRICT COURTS, METROPOLITAN TRIAL COURTS, MUNICIPAL TRIAL COURTS IN CITIES, MUNICIPAL TRIAL COURTS, MUNICIPAL CIRCUIT TRIAL COURTS, SHARIA CIRCUIT COURTS, THE OFFICE OF THE CHIEF STATE PROSECUTOR, PUBLIC ATTORNEY'S OFFICE AND THE INTEGRATED BAR OF THE PHILIPPINES

SUBJECT : SUSPENSION OF ATTY. RENATO A. IGNACIO FROM THE PRACTICE OF LAW FOR ONE (1) YEAR AND REVOCATION OF HIS NOTARIAL COMMISSION AND DISQUALIFICATION FROM REAPPOINTMENT AS NOTARY PUBLIC FOR TWO (2) YEARS

For your information and guidance, quoted hereunder is the dispositive portion of the Resolution dated 2 September 2019 of the Court (Second Division) in A.C. No. 8249, titled "Marciano A. Sambile and Lerma M. Sambile vs. Atty. Renato A. Ignacio," to wit:

WHEREFORE, for violating Section 1 (a) of Public Act No. 2103 and the Code of Professional Responsibility, the Court **SUSPENDS** respondent Atty. Renato A. Ignacio from the practice of law for one (1) year; **REVOKES** his notarial commission, if still extant; and **PROHIBITS** him from being commissioned as a notary public for two (2) years, effective immediately. Atty. Ignacio is **WARNED** that a repetition of the same or similar acts in the future shall be dealt with more severely.

Let copies of this Resolution be entered into the personal records of respondent as a member of the bar and furnished to the Bar Confidant, the Integrated Bar of the Philippines, and the Court Administrator for

circulation to all courts of the country for their information and guidance.
