: LIFTING OF DISQUALIFICATION AND PROHIBITION FROM BEING COMMISSIONED AS NOTARY PUBLIC OF ATTY. MYLENE YUMUL-ESPINA

For your information and guidance, quoted hereunder is the Resolution dated 13 March 2019 of the Court (Special Third Division) in A.C. No. 11238, titled "Atty. Mylene Yumul-Espina vs. Atty. Benedicto D. Tabaquero," to wit:

The Court NOTES complainant's Manifestation/Compliance (Re: Complainant's Service of Sanction) and Motion to Lift Disqualification from Being Commissioned as Notary Public for Two (2) Years dated January 28, 2019, stating that she has fully served her disqualification and prohibition from being commissioned as notary public for two (2) years from November 10, 2016 to November 9, 2018 and submitting certifications from the Regional Trial Courts of Pasay City, Parañaque City, Las Piñas City and Muntinlupa City, attesting that complainant has not been commissioned as notary public for the year 2016 to December 2018.

Acting on the Report and Recommendation dated February 7, 2018 (should be 2019) of the Office of the Bar Confidant (OBC), on complainant's Manifestation/Compliance. (Re: Complainant's Service of Sanction) and Motion to Lift Disqualification from being Commissioned as Notary Public for Two (2) Years dated January 28, 2019, submitting that based on records and documents herein submitted, Atty.

Mylene S. Yumul-Espina has fully served the disqualification from being commissioned as Notary Public for two (2) years, from November 10, 2016 to November 9, 2018, the Court, upon the recommendation of the OBC, resolves to LIFT the order of disqualification of Atty. Mylene S. Yumul-Espina from being commissioned as Notary Public for two (2) years, as mandated in the September 21, 2016 Decision, and she can now FILE a petition for her notary commission before a competent commissioning court.
