For the information and guidance of all first and second level courts, appended herein as Annex "A" is the approved Memorandum dated 16 December 2020 of the Committee for Office Uniforms for the Supreme Court, The Presidential Electoral Tribunal and Lower Courts on the request of the Supreme Court Employees Association (SCEA) for the relaxation of the Guidelines on the Wearing of Appropriate Office Attire thereby allowing court employees to wear wash day clothes starting 17 December 2020 to 31 January 2021, on the condition that Paragraph II of the Guidelines on the Wearing of Appropriate Office Attire* shall be strictly observed and complied with.

REQUEST TO RELAX THE RULES ON THE WEARING OF

THE PRESCRIBED OFFICE ATTIRE FROM 17 DECEMBER

In a Letter dated 10 December 2020, the Supreme Court Employees Association (SCEA), through Mr. Erwin D. Ocson, SCEA President, requests "that the Court relax the rules on the wearing of the prescribed office attire, in time for the holding of the Christmas celebration of the Supreme Court and the various offices, starting December 17, 2020 until the last working day of the year."

Administrative Circular No. 42-2103 dated 29 April 2013, and the Guidelines on the Wearing of Appropriate Office Attire (Guidelines) dated 06 December 2018, prescribe the appropriate office attire to be worn by all employees of the Court, the Presidential Electoral Tribunal and Lower Courts. Paragraph IV (B)[B.3]¹ of the said administrative circular, in relation to Paragraph II of the

B.3. Denim or "maong" pants, collarless t-shirts for men, rubber shoes, sandals, flip-flops and stepins are allowed on Fridays only.

¹ IV. Guidelines on the wearing of office uniforms and appropriate office attire:

Guidelines,² relaxes the rules on the wearing of appropriate office attire by allowing the wearing of wash day attire every Friday.

Today, the members of this Committee deliberated upon the SCEA request and also took note that a number of court employees walk, cycle, or drive a motorcycle to work due to limited public transportation brought about by the community quarantine protocols.

The Committee finds merit in the request of SCEA to relax the imposition of the Guidelines and respectfully recommends that court employees be allowed to wear wash day attire to provide them with ease of movement on the occasion of the Supreme Court's holiday festivities starting 17 December 2020 until 31 January 2021, on the condition that the Guidelines shall be strictly observed.

IN VIEW OF THE FOREGOING, the Committee on Office Uniforms for the Supreme Court, the Presidential Electoral Tribunal and Lower Courts, respectfully recommends that:

- (1) the request of the Supreme Court Employees Association (SCEA), through Mr. Erwin D. Ocson, SCEA President, for the relaxation of the rules on the wearing of the prescribed office attire, be **GRANTED**; and
- (2) the Guidelines on the Wearing of Appropriate Office Attire be **RELAXED** thereby allowing employees of the Court, the Presidential Electoral Tribunal and the Lower Courts to wear wash day clothes, **starting 17 December 2020 until 31 January 2021**, on the condition that Paragraph IV(B)[B.3] of Administrative Circular No. 42-2013, in relation to Paragraph II of the Guidelines on the Wearing of Appropriate Office Attire shall be strictly observed and complied with.
