**OCA CIRCULAR NO. 15-2002**

**TO: ALL PROCESS SERVERS OF THE LOWER COURTS**

**RE: AMENDMENT OF CIRCULAR 36-2002 (SUPREME COURT MOTORCYCLE ACQUISITION PROGRAM FOR PROCESS SERVERS)**

Pursuant to the Resolution of the Court *En Banc* dated 07 May 2002 in A.M. No. 99-8-12-SC, the period for the repayment of the interest free P50,000.00 motorcycle loan for Process Servers has been extended from three (3) years to five (5) years. Accordingly, repayment of the loan shall be made on sixty (60) equal monthly installments.
