OCA CIRCULAR NO. <u>06-2022</u>

TO:

ALL CONCERNED JUDGES AND COURT PERSONNEL OF THE FIRST AND SECOND LEVEL COURTS

SUBJECT: EXTENSION OF THE DEADLINES FOR THE SUBMISSION OF REPORTS REQUIRED ON A MONTHLY, QUARTERLY OR SEMESTRAL BASIS

As cleared with Chief Justice Alexander G. Gesmundo, and considering that many courts have been physically closed until 31 January 2022 pursuant to Memorandum Order No. 10-2022 dated 12 January 2022 and Supplemental Memorandum Order No. 10-2022-A dated 13 January 2022, not to mention that many courts in a number of regions in the country hit hard by the recent super Typhoon Odette, which regions have already been declared under a State of Calamity¹, the submission of reports required from all first and second level courts nationwide on a monthly, quarterly or semestral basis is hereby extended as follows:

The weekly reports due every Friday on videoconferencing hearings involving civil cases and criminal cases, as provided in OCA Circular Nos. 93-2020 dated 4 May 2020, 98-2020 dated 26 May 2020, and 54-2021 dated 3 May 2021, for the whole month of January 2022 and until the 2nd week of February 2022, may be compiled and all six (6) weekly reports may be submitted on or before 15 February 2022. The regular submission of the herein required weekly reports will then commence on 18 February 2022.

The submission of reports "by occurrence" or when a directive has to be complied with, such as the names of the members of the Regional or Metropolitan Trial Court Disposal Committee once this has been constituted ², copies of decisions in dismissed cases by reason of the non-appearance of police witnesses³, copies of orders of voluntary inhibition⁴ or temporary restraining orders, status quo ante orders and writs of preliminary orders⁵, if due within the month of January 2022 and up to the 2nd week of February 2022, may be compiled and submitted on or before 15 February 2022. The regular submission of any of the above reports, as the corresponding event occurs, shall commence on 16 February 2022.

Nonetheless, if the courts or judicial offices are capable of submitting their reports on time or within the prescribed deadlines, then they may proceed to do so.

Should there be a necessity to extend the submission of any of the abovementioned reports, or there are required reports that need to be evaluated further, or there may have been reports not included/listed herein, the same should be referred to the Office of the Court Administrator for appropriate action.
