SUBJECT:

SUBMISSION OF INVENTORY OF THE INFORMATION TECHNOLOGY (IT) FACILITIES, EQUIPMENT, AND ASSETS OF THE JUDICIARY, AND ACCOMPLISHMENT OF IT NEEDS SURVEY

Pursuant to Memorandum Order No. 51-2023 dated 27 March 2023 of Honorable Chief Justice Alexander G. Gesmundo, and in line with the vision in the Strategic Plan for Judicial Innovations for 2022-2027 of having a technology-driven Judiciary, there is a need to modernize and enhance court facilities to assist judges, and court personnel in their adjudication functions, as well as to identify their immediate information technology (IT) requirements.
