## OCA CIRCULAR NO. 252-2023

## TO: ALL JUDGES AND COURT PERSONNEL

## **SUBJECT:** USE OF COURIER SERVICE IN THE SUBMISSION OF APPLICATIONS AND DOCUMENTS FOR APPOINTMENT IN THE LOWER COURTS

In order to expedite and streamline the processing of appointments of lower court personnel, all applications, together with the complete documentary requirements to be filed or submitted to the Office of Administrative Services, Office of the Court Administrator (OAS-OCA), may be filed or submitted using accredited courier services.

In relation thereto, for easy reference, the following are the Courier Service Providers which were accredited pursuant to A.O. No. 242-A-2020, otherwise known as the "*Guidelines on the Accreditation of Courier Service Providers*":

- 1) Entrego Express Corporation (Entrego Express) (Valid from 21 November 2022 to 20 November 2023)<sup>1</sup>;
- JRS Business Corporation (Valid from 10 January 2023 to 09 January 2024)<sup>2</sup>;
- 3) LBC Express, Inc. (Valid from 01 February 2023 to 31 January 2024)<sup>3</sup>;
- 4) Fastrak Services, Inc. (Valid from 06 March 2023 to 5 March 2024)<sup>4</sup>; and
