OCA CIRCULAR NO. <u>279-2023</u>

SUBJECT : DISBARMENT OF ATTY. JOSE A. DIÑO, JR.

For your information and guidance, quoted hereunder is the dispositive portion of the Decision dated 02 July 2019 of the Court *En Banc* in A.C. No. 7389, entitled "Vantage Lighting Philippines, Inc., John Paul Fairclough and Ma. Cecilia G. Roque vs. Atty. Jose A. Diño, Jr.," and in A.C. No. 10596, "Atty. Jose A. Diño, Jr. vs. Attys. Paris G. Real and Sherwin G. Real," to wit:

WHEREFORE, premises considered, Atty. Jose A. Diño, Jr. is hereby DISBARRED FROM THE PRACTICE OF LAW EFFECTIVE IMMEDIATELY upon his receipt of this Decision. Let his name be stricken off the Roll of Attorneys.

On the other hand, the administrative complaint against Attys. Paris G. Real and Sherwin G. Real is **DISMISSED** for failure of Atty. Jose A. Diño, Jr. to prove his case against them.

Let copies of this Decision be furnished to the Office of the Bar Confidant to be appended to Atty. Jose A. Diño, Jr.'s personal record as an attorney, to the Integrated Bar of the Philippines, and to all courts in the country for their information and guidance. May this Decision serve as a warning to all lawyers that this Court takes seriously any imputation that would harm the integrity of our courts and the judicial system.

In a Resolution dated 18 April 2023, acting on the 'Omnibus Motion to Reconsider, Reverse and Set Aside the Court's Decision (dated July 2, 2019) and/or to Remand the RE: DISBARMENT OF ATTY. JOSE A. DIÑO, JR.

Complaint for Proper Investigation with Very Urgent Verified Application to Lift/Suspend *Pendente Lite* the Immediate Effectivity of the Imposed Penalty' dated September 19, 2019 filed by respondent/complainant Jose A. Diño, Jr., the. Court Resolved to **DENIED WITH FINALITY** the said Omnibus Motion as no substantial matters were presented to warrant the reversal of the questioned Decision.
