OCA CIRCULAR NO. 304-2023

SUBJECT: LIFTING OF THE SUSPENSION FROM THE PRACTICE OF LAW OF ATTY. FERDINAND N. TALABONG IN ADMINISTRATIVE CASE (A.C.) NO. 13389

For information and guidance, quoted hereunder, and appended as Annex "A" is the Resolution dated 20 February 2023 of the Court (First Division) in A.C. No. 13389, titled "Hector Capinpin v. Attys. Donabella C. Talabong and Ferdinand N. Talabong," to wit:

The Court resolves to *NOTE* the Manifestation of respondent Atty. Ferdinand N. Talabong, in compliance with the Resolution dated August 31, 2022, stating that he formally started his suspension on October 7, 2022 and refrained from exercising any act considered as practice of law until January 7, 2023.

Pursuant to the guidelines outlined by the Court in its Decision dated 10 January 2023 in A.C. No. 11032, titled "Re: Order dated 01 October 2015 in Criminal Case No. 15-318727-34, Regional Trial Court (RTC), Branch 49, Manila, against Atty. Severo L. Brillantes, governing the lifting of the penalty of suspension imposed against members of the Bar, the order of suspension shall be automatically lifted upon submission by the respondent lawyer of such Sworn Statement that he or she has completed the service of suspension¹.

Accordingly, insofar as the Court's Resolution dated 31 August 2022 in A.C. No. 13389 is concerned, the therein imposed suspension from the practice of law of Atty. Ferdinand N. Talabong is deemed LIFTED.
