OCA CIRCULAR NO. 337-2023

SUBJECT: LIFTING OF THE SUSPENSION FROM THE PRACTICE OF LAW OF ATTY. HIPOLITO C. SALATAN

In its Decision dated 08 July 2020 in A.C. No. 12551, titled "Valentino C. Leano v. Atty. Hipolito C. Salatan," the Court (Second Division), among others, (a) found respondent GUILTY of violating of the 2004 Rules on Notarial Practice and the Code of Professional Responsibility; and (b) SUSPENDED him from the practice of law for a period of one (1) year.

The Office of the Bar Confidant (OBC), in its 1st Indorsement dated 13 September 2023, furnished the Office of the Court Administrator a copy of the <u>Sworn Statement on the Service of One-Year Suspension from the Practice of Law</u> dated 08 September 2023 filed by Atty. Salatan.

Pursuant to the guidelines outlined by the Court in its Decision dated 10 January 2023 in A.C. No. 11032, titled "Re: Order dated 01 October 2015 in Criminal Case No. 15-318727-34, Regional Trial Court (RTC), Branch 49, Manila, against Atty. Severo L. Brillantes governing the lifting of the penalty of suspension imposed against members of the Bar, the order of suspension shall be automatically lifted upon submission by the respondent lawyer of such Sworn Statement that he or she has completed the service of suspension¹.

Accordingly, insofar as the Court's Decision dated 08 July 2020 in A.C. No. 12551 is concerned, the therein imposed

suspension from the practice of law of Atty. Hipolito C. Salatan is deemed LIFTED.
