**OCA CIRCULAR NO. 340-2023**

**SUBJECT : LIFTING OF THE SUSPENSION FROM THE PRACTICE OF LAW OF ATTY. ROBERTO I. ACDA**

In its Resolution dated 22 July 2019 in A.C. No. 8894, titled "**Jocelyn S. Acosta v. Attys. Jose S. Alvarez, Jr., Roberto I. Acda, and Delfin Agcaoili, Jr.**," the Court (First Division) **ADOPTED** and **ACCEPTED**, among others, the finding and recommendation of the IBP's Investigating Commissioner to **SUSPEND** Atty. Roberto I. Acda from the practice of law for six (6) months.

The Office of the Bar Confidant (OBC), in its 1<sup>st</sup> Indorsement dated 19 September 2023, furnished the Office of the Court Administrator a copy of the **Affidavit of Compliance** dated 14 August 2023 filed by Atty. Acda.

Pursuant to the guidelines outlined by the Court in its Decision dated 10 January 2023 in A.C. No. 11032, titled "*Re: Order dated 01 October 2015 in Criminal Case No. 15-318727-34, Regional Trial Court (RTC), Branch 49, Manila, against Atty. Severo L. Brillantes*" governing the lifting of the penalty of suspension imposed against members of the Bar, the order of suspension shall be automatically lifted upon submission by the respondent lawyer of such Sworn Statement that he or she has completed the service of suspension<sup>1</sup>.

Accordingly, insofar as the Court's Resolution dated 22 July 2019 in A.C. No. 8894 is concerned, the therein imposed suspension from the practice of law of Atty. Roberto I. Acda is deemed **LIFTED**.
