OCA CIRCULAR NO. <u>341-2023</u>

- TO THE COURT OF APPEALS, SANDIGANBAYAN, COURT OF TAX APPEALS, REGIONAL TRIAL COURTS, SHARI'AH DISTRICT COURTS. - SUBJECT : LIFTING OF THE SUSPENSION FROM THE PRACTICE OF LAW OF ATTY. MERLE M. TELAN

In its Resolution dated 17 August 2022 in A.C. No. 13392, titled *"Reydante Sager v. Atty. Merle Telan,"* the Court (First Division), among others, (a) found respondent GUILTY of violating of the 2004 Rules on Notarial Practice, as amended by A.M. No. 02-8-13-SC; and (b) SUSPENDED her from the practice of law for six (6) months.

The Office of the Bar Confidant, in its 1st Indorsement dated 18 September 2023, furnished the Office of the Court Administrator a copy of the <u>Manifestation with Submission</u> (<u>Re: Sworn Statement on Service of Suspension</u>) dated 10 August 2023 and <u>Sworn Statement</u> dated 11 August 2023 filed by Atty. Telan.

Pursuant to the guidelines outlined by the Court in its Decision dated 10 January 2023 in A.C. No. 11032, titled "*Re*: Order dated 01 October 2015 in Criminal Case No. 15-318727-34, Regional Trial Court (RTC), Branch 49, Manila, against Atty. Severo L. Brillantes governing the lifting of the penalty of suspension imposed against members of the Bar, the order of suspension shall be automatically lifted upon submission by the respondent lawyer of such Sworn Statement that he or she has completed the service of suspension¹.
