**OCA CIRCULAR NO. 04-2024**

**TO: THE CONCERNED JUDGES AND COURT PERSONNEL OF THE FIRST AND SECOND LEVEL COURTS IN THE ANGELES CITY HALL OF JUSTICE**

**SUBJECT: ATTENDANCE AND PARTICIPATION TO THE ACTIVITY OF THE ANGELES CITY JUSTICE ZONE**


