**OCA CIRCULAR NO. 385-2023**

**TO : THE COURT OF APPEALS, SANDIGANBAYAN, COURT OF TAX APPEALS, REGIONAL TRIAL COURTS, SHARIAH DISTRICT COURTS, METROPOLITAN TRIAL COURTS, MUNICIPAL TRIAL COURTS IN CITIES, MUNICIPAL TRIAL COURTS, MUNICIPAL CIRCUIT TRIAL COURTS, SHARIAH CIRCUIT COURTS, THE OFFICE OF THE CHIEF STATE PROSECUTOR, PUBLIC ATTORNEY'S OFFICE, AND THE INTEGRATED BAR OF THE PHILIPPINES**

**SUBJECT : LIFTING OF THE SUSPENSION FROM THE PRACTICE OF LAW OF ATTY. AVERILL J. AMOR**

In its Resolution dated 10 July 2019 in A.C. No. 11582, titled "*Executive Suites Homeowners Association, Inc. vs. Atty. Averill J. Amor*," the Court (First Division), among others, found respondent **GUILTY** of **GROSS MISCONDUCT** for violating Rule 1.01 of the Code of Professional Responsibility and **SUSPENDED** him from the practice of law for **one (1) year**.

The Office of the Bar Confidant, in its 1<sup>st</sup> Indorsement dated 17 November 2023, furnished the Office of the Court Administrator a copy of the Sworn Statement dated 06 November 2023 filed by Atty. Amor.

Pursuant to the guidelines outlined by the Court in its Decision dated 10 January 2023 in A.C. No. 11032, titled "*Re: Order dated 01 October 2015 in Criminal Case No. 15-318727-34, Regional Trial Court (RTC), Branch 49, Manila, against Atty. Severo L. Brillantes*" governing the lifting of the penalty of suspension imposed against members of the Bar, the order of suspension shall be automatically lifted upon submission by the respondent lawyer of such Sworn Statement that he or she has completed the service of suspension.<sup>1</sup>

Accordingly, insofar as the Court's Resolution dated 10 July 2019 in A.C. No. 11582 is concerned, the therein imposed suspension from the practice of law of Atty. Averill J. Amor is deemed **LIFTED**.
