## OCA CIRCULAR NO. 388-2023

SUBJECT: LIFTING OF THE SUSPENSION FROM THE PRACTICE OF LAW OF ATTY. DANILO B. BAÑARES

In its Decision dated 20 June 2018 in A.C. No. 11396, titled "Franco B. Gonzales v. Atty. Danilo B. Bañares," the Court (Second Division), among others, SUSPENDED him from the practice of law for six (6) months and revocation of his notarial commission and disqualification from reappointment as a notary public for two (2) years.

The Office of the Bar Confidant, in its 1<sup>st</sup> Indorsement dated 07 November 2023, furnished the Office of the Court Administrator a copy of the <u>Sworn Statement</u> dated 23 October 2023 filed by Atty. Bañares.

Pursuant to the guidelines outlined by the Court in its Decision dated 10 January 2023 in A.C. No. 11032, titled "Re: Order dated 01 October 2015 in Criminal Case No. 15-318727-34, Regional Trial Court (RTC), Branch 49, Manila, against Atty. Severo L. Brillantes governing the lifting of the penalty of suspension imposed against members of the Bar, the order of suspension shall be automatically lifted upon submission by the respondent lawyer of such Sworn Statement that he or she has completed the service of suspension.<sup>1</sup>

Accordingly, insofar as the Court's Resolution dated 20 June 2018 in A.C. No. 11396 is concerned, the therein imposed suspension from the practice of law of Atty. Danilo B. Bañares is deemed LIFTED.
