## OCA CIRCULAR NO. <u>390-2023</u>

- SUBJECT : LIFTING OF THE SUSPENSION FROM THE PRACTICE OF LAW OF ATTY. VICTOR M. MANLAPAZ

In its Resolution dated 29 March 2023 in A.C. No. 13622, titled "Gilbert T. Vigilla v. Atty. Victor M. Manlapaz," the Court (First Division), among others, found respondent GUILTY of violating Rules 18.03 and 18.04, Canon 18 of the Code of Professional Responsibility and SUSPENDED him from the practice of law for six (6) months.

The Office of the Bar Confidant, in its 1<sup>st</sup> Indorsement dated 23 November 2023, furnished the Office of the Court Administrator a copy of the <u>Sworn Statement of Compliance</u> dated 23 November 2023 filed by Atty. Manlapaz.

Pursuant to the guidelines outlined by the Court in its Decision dated 10 January 2023 in A.C. No. 11032, titled "Re: Order dated 01 October 2015 in Criminal Case No. 15-318727-34, Regional Trial Court (RTC), Branch 49, Manila, against Atty. Severo L. Brillantes governing the lifting of the penalty of suspension imposed against members of the Bar, the order of suspension shall be automatically lifted upon submission by the respondent lawyer of such Sworn Statement that he or she has completed the service of suspension.<sup>1</sup>
