## OCA CIRCULAR NO. 40-2024

TO

SUBJECT: LIFTING OF THE SUSPENSION FROM THE PRACTICE OF LAW OF ATTY. PAUL VINCENT G. VILLEGAS

In its Resolution dated 03 July 2023 in A.C. No. 11090, titled "Judy L. Pancrudo v. Attys. Nestor E. Cajes, Jr. and Paul Vincent G. Villegas," the Court (First Division), among others, SUSPENDED him from the practice of law for one (1) month.

The Office of the Bar Confidant, in its 1st Indorsement dated 02 February 2024, furnished the Office of the Court Administrator a copy of the <u>Affidavit of Complete Service/Compliance of Suspension</u> dated 14 October 2023 filed by Atty. Villegas.

Pursuant to the guidelines outlined by the Court in its Decision dated 10 January 2023 in A.C. No. 11032, titled "Re: Order dated 01 October 2015 in Criminal Case No. 15-318727-34, Regional Trial Court (RTC), Branch 49, Manila, against Atty. Severo L. Brillantes governing the lifting of the penalty of suspension imposed against members of the Bar, the order of suspension shall be automatically lifted upon submission by the respondent lawyer of such Sworn Statement that he or she has completed the service of suspension.<sup>1</sup>

Accordingly, insofar as the Court's Resolution dated 03 July 2023 in A.C. No. 11090 is concerned, the therein imposed suspension from the practice of law of Atty. Paul Vincent G. Villegas is deemed LIFTED.
