## SUBJECT : LIFTING OF THE SUSPENSION FROM THE PRACTICE OF LAW OF ATTY. ADAN MARCELO B. BOTOR

In its Resolution dated 28 November 2022 in A.C. No. 11554, titled *"Roderick V. Mago v. Atty. Adan Marcelo B. Botor,"* the Court (Third Division), among others, SUSPENDED him from the practice of law for six (6) months.

The Office of the Bar Confidant, in its 1<sup>st</sup> Indorsement dated 06 February 2024, furnished the Office of the Court Administrator a copy of the <u>Sworn Statement</u> dated 13 November 2023 filed by Atty. Botor.

Pursuant to the guidelines outlined by the Court in its Decision dated 10 January 2023 in A.C. No. 11032, titled "Re: Order dated 01 October 2015 in Criminal Case No. 15-318727-34, Regional Trial Court (RTC), Branch 49, Manila, against Atty. Severo L. Brillantes governing the lifting of the penalty of suspension imposed against members of the Bar, the order of suspension shall be automatically lifted upon submission by the respondent lawyer of such Sworn Statement that he or she has completed the service of suspension.<sup>1</sup>

Accordingly, insofar as the Court's Resolution dated 28 November 2022 in A.C. No. 11554 is concerned, the therein
