OCA CIRCULAR No. 105-2024

**TO: ALL CONCERNED JUDGES AND COURT PERSONNEL OF THE FIRST AND SECOND LEVEL COURTS IN REGION X**

**SUBJECT: CARAVAN ON THE ESTABLISHMENT OF THE OFFICE OF THE REGIONAL COURT MANAGER FOR REGION X ON APRIL 19, 2024 IN BUTUAN CITY, AGUSAN DEL NORTE**

By virtue of the *En Banc* Resolution dated February 27, 2024 in A.M. No. 24-02-18-SC (*Re: Proposed Creation and Pilot Implementation of the Offices of the Regional Managers as Key Area of Focus in the Modernization of the Office of the Court Administrator*), Region X was identified as one of the six (6) areas where the establishment of the Office of the Regional Court Manager (ORCM) will be pilot tested this coming June 2024.

In order to introduce to the judges and court personnel of Region X the background and concept of the ORCM, as well as gather feedback on the process that will be assigned, a caravan thereon will be conducted by the SC Interim Planning Development Office, in coordination with the Office of the Court Administrator, in Butuan City, Agusan del Norte, which is the location contemplated for the ORCM in Region X.

As such and based on the results of the survey earlier conducted for the purpose, the following judges and court personnel listed in Table I are authorized to physically attend the caravan on April 19, 2024 from 1:00 to 5:00 p.m. in Butuan City, Agusan del Norte.
