LIFTING OF THE REVOCATION OF NOTARIAL COMMISSION AND PROHIBITION FROM BEING COMMISSIONED AS NOTARY PUBLIC OF ATTY. REINIER JOHN G. BROFAR

For information and guidance, quoted hereunder is the dispositive portion of the Resolution dated 22 January 2024 of the Court (First Division) in A.C. No. 13328, titled "Ever Electrical Mfg., Inc., represented by Reuel T. Cachuella v. Atty. Reinier John G. Brofar," to wit:

The Court furthermore resolved to:

- NOTE the respondent's Sworn Statement dated November 20, 2023 stating that on May 17, 2023, he effectively learned of the Resolution dated March 15, 2023 which revoked his notarial commission and prohibited him from being appointed as Notary Public for a period of six months; that for the period of May 17, 2023 to November 17, 2023, he ceased to act as notary public and/or perform notarial acts pursuant to the said resolution; and that in view of the lapse of the period of prohibition on appointment as Notary Public, he now intends to apply for reappointment/reinstatement his of Commission No. 27-2024 before the Regional Trial Court of Calamba City;
- (2) GRANT the respondent's Urgent Motion to Lift the Prohibition for Appointment as Notary Public dated November 27, 2023, praying that an order be issued lifting the prohibition for appointment as notary

public thereby permitting him to apply for appointment/reappointment as notary public; and

(3) *ALLOW* Atty. Reinier John G. Brofar to *APPLY* for notarial commission, effective immediately.

*NO FURTHER* pleadings, motions, letters or other communications shall be entertained herein.

The Report and Recommendation dated January 8, 2024 of the Office of the Bar Confidant is *NOTED*.
