## OCA CIRCULAR NO. <u>111-2024</u>

SUBJECT: LIFTING OF THE SUSPENSION FROM THE PRACTICE OF LAW OF ATTY. MARLO IGNACIO V. QUADRA AND ATTY. JOHNEVA L. PASTOR-QUADRA

In its Resolution dated 7 December 2022 in A.C. No. 11437, titled "Ramon L. Labo, Jr. v. Atty. Marlo Ignacio V. Quadra and Atty. Johneva L. Pastor-Quadra," the Court (Second Division), among others, SUSPENDED them from the practice of law for six (6) months.

The Office of the Bar Confidant, in its 1<sup>st</sup> Indorsement dated 16 April 2024, furnished the Office of the Court Administrator a copy of the <u>Compliance and Affidavit (Compliance with Conditions of Suspension from the Practice of Law)</u> dated 13 March 2024 filed by Atty. Quadra and Atty. Pastor-Quadra.

Pursuant to the guidelines outlined by the Court in its Decision dated 10 January 2023 in A.C. No. 11032, titled "Re: Order dated 01 October 2015 in Criminal Case No. 15-318727-34, Regional Trial Court (RTC), Branch 49, Manila, against Atty. Severo L. Brillantes governing the lifting of the penalty of suspension imposed against members of the Bar, the order of suspension shall be automatically lifted upon submission by the respondent lawyer of such Sworn Statement that he or she has completed the service of suspension.<sup>1</sup>
