## OCA CIRCULAR NO. <u>119-2024</u>

- SUBJECT : LIFTING OF THE SUSPENSION FROM THE PRACTICE OF LAW OF ATTY. ROLINDO A. NAVARRO

In its Resolution dated 21 June 2023 in A.C. No. 12231, titled "Manuel O. Lim, Jr., Santiago O. Lim, Edgardo O. Lim, Elizabeth O. Lim, Helen O. Lim, and Imelda O. Lim versus Atty. Rolindo A. Navarro," the Court (Third Division), among others, SUSPENDED him from the practice of law for one (1) month.

The Office of the Bar Confidant, in its 1<sup>st</sup> Indorsement dated 15 April 2024, furnished the Office of the Court Administrator a copy of the <u>Manifestation, Compliance and Motion to Lift</u> <u>Order of Suspension</u> dated 22 January 2024 filed by Atty. Navarro.

Pursuant to the guidelines outlined by the Court in its Decision dated 10 January 2023 in A.C. No. 11032, titled "Re: Order dated 01 October 2015 in Criminal Case No. 15-318727-34, Regional Trial Court (RTC), Branch 49, Manila, against Atty. Severo L. Brillantes governing the lifting of the penalty of suspension imposed against members of the Bar, the order of suspension shall be automatically lifted upon submission by the respondent lawyer of such Sworn Statement that he or she has completed the service of suspension.<sup>1</sup>
