**TO : ALL JUDGES AND COURT PERSONNEL (WHO ARE IBP MEMBERS) OF FIRST AND SECOND LEVEL COURTS**

**SUBJECT : REVISED SCHEDULE FOR THE CODE OF PROFESSIONAL RESPONSIBILITY AND ACCOUNTABILITY [CPRA] NATIONWIDE ROLLOUT**


