

OCA CIRCULAR NO. <u>136-2024</u>

- SUBJECT : LIFTING OF THE SUSPENSION FROM THE PRACTICE OF LAW OF ATTY. FAUSTINO C. TUMAMAK, JR.

In its Resolution dated 20 June 2016 in A.C. No. 11101, titled "Vivian D. Sumile-Walsh vs. Atty. Faustino C. Tumamak, Jr.," the Court (Third Division), among others, SUSPENDED him from the practice of law for one (1) year and ORDERED to return the amount of P960,000.00 to complainant Vivian D. Sumile-Walsh.

The Office of the Bar Confidant, in its 1st Indorsement dated 25 April 2024, furnished the Office of the Court Administrator a copy of the <u>Manifestation with Motion to Lift Order of</u> <u>Suspension and Exemption on the Mandatory Continuing</u> <u>Legal Education Compliance during the Period of Suspension</u> dated 21 June 2023 filed by Atty. Tumamak, Jr.

Pursuant to the guidelines outlined by the Court in its Decision dated 10 January 2023 in A.C. No. 11032, titled "Re: Order dated 01 October 2015 in Criminal Case No. 15-318727-34, Regional Trial Court (RTC), Branch 49, Manila, against Atty. Severo L. Brillantes governing the lifting of the penalty of suspension imposed against members of the Bar, the order of suspension shall be automatically lifted upon submission by the RE: Lifting of the Suspension from the Practice of Law of Atty. Faustino C. Tumamak, Jr.

respondent lawyer of such Sworn Statement that he or she has completed the service of suspension.¹

Accordingly, insofar as the Court's Resolution dated 20 June 2016 in A.C. No. 11101 is concerned, the therein imposed suspension from the practice of law of Atty. Faustino C. Tumamak, Jr. is deemed LIFTED.
