OCA CIRCULAR NO. <u>137-2024</u>

- SUBJECT : LIFTING OF THE SUSPENSION FROM THE PRACTICE OF LAW OF ATTY. CESAR R. CARREON III

In its Resolution dated 04 March 2020 in A.C. No. 8120, titled *"Karen M. Silverio-Buffe v. Atty. Cesar R. Carreon III,"* the Court (Second Division), among others, SUSPENDED him from the practice of law for one (1) year and revocation of his notarial commission with prohibition from being commissioned as a notary public for two (2) years.

The Office of the Bar Confidant, in its 1st Indorsement dated 19 April 2024, furnished the Office of the Court Administrator a copy of the <u>Manifestations</u> dated 01 April 2024 filed by Atty. Carreon III.

Pursuant to the guidelines outlined by the Court in its Decision dated 10 January 2023 in A.C. No. 11032, titled "Re: Order dated 01 October 2015 in Criminal Case No. 15-318727-34, Regional Trial Court (RTC), Branch 49, Manila, against Atty. Severo L. Brillantes governing the lifting of the penalty of suspension imposed against members of the Bar, the order of suspension shall be automatically lifted upon submission by the respondent lawyer of such Sworn Statement that he or she has completed the service of suspension.¹

RE: Lifting of the Suspension from the Practice of Law of Atty. Cesar R. Carreon III
